1. I understand that both my attendance and my child(ren)'s attendance at all regularly scheduled club meetings are mandatory and that it is my responsibility to notify the appropriate CCofPA Club Coordinator(s) as soon as possible if either is unable to attend because of a sickness or an emergency situation.
2. I understand I will be expected to contribute my time as a volunteer to support CCofPA's efforts. This will include faithful attendance and participation in the weekly club meetings and parent meetings, as well as helping organize and host local tournaments; traveling with the club in the capacity of chaperone, judge, or timekeeper; and/or fulfilling "Operational Responsibilities" as outlined in the current CCofPA Club Handbook. To that end, I agree to inform appropriate CCofPA Club Coordinators as soon as possible if I am unable to attend a club meeting because of an emergency and to secure a replacement for the job area to which I am assigned for that particular club meeting.
3. In addition to the work accomplished at the regularly scheduled club meetings, I understand CCofPA expects all students to spend the necessary time at home to adequately prepare for each club meeting or event. I understand all homework assignments must be completed and submitted or evidenced punctually; this includes the prompt and complete submission of homework assignments as well as the selection and memorization of speeches. I agree to hold my child(ren) accountable to fulfill these academic requirements for CCofPA. I also understand that repeated failure to complete the necessary work in a timely manner is grounds for disciplinary action.
4. If applicable, once my child has committed to any partnership with another student, I understand he/she is bound to that partnership for the duration of the competitive season and to the guidelines stated in the Partnership Agreement. I also understand that anyone who withdraws from club meetings and/or partnership or individual responsibilities mid-season without just cause will have their membership terminated and will not be accepted back into club membership the following season.
5. I agree to insure that my child will be dressed appropriately according to the dress code outlined in the current CCofPA Club Handbook. I agree to assure that my child's manner of dress is always neat, clean, modest, inoffensive, and is not a distraction to others by calling undue attention to self. I also understand that if my child's dress does not meet CCofPA standards, they will be asked to return home to change before participating in the club session, tournament, or other events.
6. I commit to being an example to my child by agreeing to keep the lines of communication open with CCofPA leadership and other club members. Because this is a Christian organization, I understand it is my glad privilege to strive to glorify God in both my words and actions and to commit to solving areas of conflict by using Matthew 18:15-17 and the "Peacemaker's Pledge". I also agree to participate in third-party mediation, as required.
7. I understand that Christian Communicators of Pennsylvania does not keep grades or issue a report card and that any necessary home-school record keeping and homework accountability is my responsibility.
8. I authorize the administration of emergency medical treatment to my child(ren). I understand every attempt will be made to contact me or the person I designate in my absence in the event medical intervention is necessary.
9. I have read the Student Member Agreement, Student Partnership Agreement, Evidence Exchange Standards, The Peacemaker, and the CCofPA Club Handbook, and I agree to follow the guidelines as outlined in them. I have discussed the applicable responsibilities and requirements with my children and assure that they understand their responsibilities, as well. I understand that refunds will not be given to those who are dismissed from club due to disciplinary action or to those who leave mid-season.

As a club member of Christian Communicators of Pennsylvania, I understand and agree to fulfill my parental responsibilities, to adhere to CCofPA guidelines, to hold my child(ren) accountable to adhere to CCofPA guidelines, and to support CCofPA leadership in their enforcement. I understand that violation of these standards may require disciplinary action in an effort to make restitution or reconciliation and that failure to comply with such action will result in the termination of CCofPA membership without a refund.
