

1. I understand I am making a commitment to Christian Communicators of Pennsylvania from the onset of club meetings until the end of the competitive season (NCFCA National Tournament). This means I have seriously evaluated the time and work required, and I agree to fulfill the responsibilities and commitments as set forth in the CCofPA Handbook, this Student Member Agreement, the Partnership Agreement (if applicable), and the Debate Evidence & Information Exchange Standards (if applicable) for the duration of the competitive season.
2. I agree to faithfully attend and be punctual for all club meetings and events and to remain for their entirety. Since club attendance is mandatory, I understand I must notify the appropriate CCofPA Coordinator(s) immediately, if I am unable to attend any scheduled club session because of sickness or an emergency situation.
3. I agree to spend the necessary time each week researching the IE and/or debate topic(s), organizing my information, memorizing my speech(es), studying debate theory, and/or preparing for other IE or debate events, as applicable. I agree to arrive prepared with the required homework assignments fully completed and with the materials and resources necessary to participate in the weekly club meetings, competitions, tournaments, workshops, conferences, and/or any other CCofPA activity. This includes the timely memorization of IE speeches, as well as the submission of any homework assignment within the designated time allowed.
4. I agree to dress according to the established "Dress Code" and to act in accordance with the "Code of Conduct" established in CCofPA's current Club Handbook. I understand that violators of the "Dress Code" will be dismissed from the activity to change into acceptable attire and that offenders of the "Code of Conduct" are subject to disciplinary action. Failure to comply with such action will result in removal from CCofPA membership.
5. I understand that securing a debate and/or IE partner is my parents' and my responsibility. Once my partnership is established, I agree to fulfill the requirements of the relationship as outlined by the CCofPA Partnership Agreement and the Evidence Exchange Standards for the duration of our league's competitive season. I also understand that my debate and/or IE partnership is automatically terminated when the competitive season ends, unless both students' parents have discussed the relationship and decided otherwise.
6. If I am a member of CCofPA Debate Club, I agree to freely share evidence, briefs, blocks, and other case information with my fellow members. I understand that this is an essential element in striving to accomplish the "Objectives" as outlined in the current CCofPA Club Handbook. I promise to follow the guidelines set forth by CCofPA leadership for the exchange of debate evidence.
7. I understand that, as a debater, it is an ethical violation of club confidentiality to provide information about my fellow club members' affirmative cases or evidence and briefs against them to teams outside CCofPA membership at any time. Additionally, it is a breach of trust to do likewise for a specific team within the club membership if they compete against one another during tournament competition. I understand that violation of this standard is grounds for discipline or immediate dismissal.
8. I understand that information provided under the password protected area on CCofPA's web site is for club member use only; therefore, I agree to maintain the level of privacy required by prohibiting any non-member access to the password. I also understand that divulging such information will result in immediate dismissal from CCofPA without a refund.
9. Because this is a Christian organization, I understand my responsibility to behave in a Christ-like manner at all times. Therefore, I will exhibit respect for CCofPA leadership and for parent members, as well as demonstrate a kind, polite, and respectful attitude toward other student club members. If I am offended by a club member, I will go directly to that member to resolve the matter in accordance with Matthew 5:23-25, Matthew 18:15-17, and the Peacemaker's Pledge; I will not talk to another club member about the issue (gossip). In addition, I will submit to third-party mediation in order to completely resolve a situation, should the need arise.
